THE FORESTS ORDINANCE, 1958

THE TAMA ABU PROTECTED FOREST (1ST EXTENSION) NOTIFICATION, 2014

[Made under section 26(1)]

Pursuant to section 26(1) of the of the Forests Ordinance, 1958 [*Cap. 126*], the Minister for Resource Planning and Environment has made the following Notification:

1. This Notification may be cited as the Tama Abu Protected Forest (1st Extension), 2014.
2. The area intended to be constituted as the Tama Abu Protected Forest (1st Extension) is described in the First Schedule and to be known as the “Tama Abu Protected Forest 1st Extension”.
3. Any person who have any rights or privileges in or over the land described in the First Schedule are required to submit their claims in writing or in person to the Regional Forests Officer, Regional Forests Office, Miri within sixty (60) days from the date of publication of this Notification together with evidence in support of such claims.
4. Upon the expiry of the period of sixty (60) days from the date of publication of this Notification, no claim to any rights or privileges in or over the area intended to be constituted a Protected Forest shall be entertained and such rights or privileges, if any, shall be deemed to have been abandoned or the exercise thereof has been waived, by any person entitled thereto.

THE LAND (NATIVE CUSTOMARY RIGHTS) (No. 51) 2014 DIRECTION

(Made under section 5(3) and (4))

In exercise of the powers conferred by section 5(3) and (4) of the Land Code [*Cap. 81*], the Minister of Resource Planning and Environment has made the following direction:

1. This Direction may be cited as the Land (Native Customary Rights) (No. 51) 2014 Direction, and shall come into force on the 11th day of August, 2014.
2. All that area of land situated at Sungai Ahi, Bunan, Serian, Samarahan known as Plot A, containing an area of approximately 6.5564 hectares, as more particularly delineated on the plan (Print No. 5/AQ/8D/21/2013) and edged thereon in red, is required for a public purpose, namely for the construction of access road for irrigation scheme (Paya Terbat Irrigation Scheme, Samarahan Division). Further details regarding the land can be obtained from the office of the Superintendent of Lands and Surveys, Samarahan Division, Samarahan.
3. As the aforesaid land is required by the Government, the Government has to acquire it. In consequence thereof, all native customary rights over such land shall be taken over by the Government subject to the payment of compensation under section 5(3) of the Land Code.

4. As from the date of coming into force of this Direction, all native customary rights over the said land shall cease to subsist and the said land shall revert back to the Government for the aforesaid public purpose.

5. Any person having any lawful claim to native customary rights over the said land or any part thereof and whose rights are affected by this Direction shall within sixty (60) days from the date of publication of this Direction in a newspaper circulated in Sarawak, submit his claim, together with evidence in support thereof, to the Superintendent, Lands and Surveys Department, Samarahan Division, Samarahan in a form prescribed by the Superintendent and obtainable from his office in the said Department. Compensation will be paid to those claimants with proven native customary rights over the said land or any part thereof in accordance with the provisions of the Land Code.
